NORTHWEST MICHIGAN HEALTH DEPARTMENT REPORT AND PRESENTATION MILTON TOWNSHIP "TIME OF TRANSFER ORDINANCE" Well and Septic Systems

Milton Township Ordinance requires an inspection of the water and waterwaste systems prior to the time of property transfer. To assure consistency of inspections and accurately determine compliance with the District Sanitary Code, the Township entered onto an Inter-Governmental Agreement requiring the Health Department of NW MI to conduct all "Time of Transfer" evaluations and to annually report to the Township. The cost of the "Time of Transfer" evaluation is paid directly to the NW MI Health Department at the cost of \$278.00, and the evaluation being completed within two (2) weeks. The program has been very successful and a written evaluation report is provided to the applicant. The Health Department sends out letters to the local realtors to inform them and educate them of the process. Currently the Health Department offers existing system evaluations prior to requesting a building permit.

Trumble directed Smith to check with Antrim County to see if the County would be considering a similar ordinance in the near future. Also that Smith select a local realtor to attend a commission meeting to present their point of view regarding a "Time of Transfer" Ordinance.

Tom Frey requested that the commission consider placing an additional Public Comment at the end of Agenda.
