The Chairperson Carrie Hebden called the meeting to order at 5:17 PM.

PUBLIC COMMENT: FHT Supervisor Terry Smith attended the meeting to announce and introduce new member of the Parks and Recreation Commission Rebecca Rankin. She will be replacing Stephanie Hebden who resigned in early October. He spoke on her affiliation with the Friends of Glacial and will be acting as the liaison between the two groups.

Smith also reported on the FHT parcel containing 30 acres property in mid-November a survey is scheduled to identify the current legal description and to identify the 33 feet wide easement. Smith left meeting at 5:30 p.m.

Glacial Hills – Dean Crandall

Working to update the Township, Village and County Intergovernmental Agreement with Friends of Glacial Hills. Discussion followed. The future addition of proposed trails and current plan to expand the parking lot as proposed by the Friends of Glacial. The parking lot expansion appears to be at or very near the location that the commission had discussed the plan for a future Pavilion.

Conservancy will be working with the Township on acquisition

Pinnel Road Ending:

Hebden reported that Burt Thompson has added Pinnel Road to the Road Commissions list of projects. Trumble and Crandall both reported that they have discussed this site with the FHT Supervisor Terry Smith.
