AGENDA:

FHT COTTAGE DRIVE FAMILY PARK:

Dean Crandall reported that Great Lakes Energy has measured the site for power installation and the lease agreement has been signed by all parties. The next step will be for the power company to gain access to site before the power pole will be set.

TOUR AND ASSESSMENT OF ALL PARKS AND ROAD ENDING REVIEW AND DISCUSSION:

Corey Arsnoe attended to assist in the discussions and members findings of the tour and to offer input and/or suggestions.

Gorham Beach Park – That fencing be added fencing and check on leaning trees over property line and remove as needed.

Intermediate Lake/Snowflake Road Ending – South side (3) slats to be replaced.

Torch Lake Family Park – Fill eroded area with rocks and add a couple of terraces with plantings to secure hill.

620 Road Ending/Meeders –Reinforce shoreline (pull rocks back to water's edge to support shoreline).

Jacob's Road Ending – Repair fence.

Pinnel Road Ending – Replace faded sign and consider options and plans for a terrace with steps.

Steiner Road Ending/Sunset Torch Condo – Fence repair.

Dockside Road Ending – No improvements needed.

DNR/Dewey Boat Launch – Additional fencing and picnic table installation.

Arrowhead Park – Add Mulch to pathway.

Green Street/Niepoth Road Ending – Replace faded sign.

FHT Cottage Drive Family Park/Miley's – Reinforce fence that is being taken down by neighbor and trim pine trees that cover township signs as needed.

Pleasant Street Road Ending – Replace faded sign.

Lynn Road Ending/Lake Bellaire – Reposition rocks at the water's edge to reinforce shoreline.

Lessard Lane Road Ending – Replace sections of split rail fence as needed.

Eckhardt Road Ending – Trim and keep watch on cedar trees that are leaning towards the neighbor's property.

Loon Preserve – Remove and trim trees along path as needed.

Grass Lake Road Ending – No improvements needed.

Dean Crandall left meeting at 7:20 p.m.

Corey Arsnoe reported that the dock at the FHT Family Park will be installed this week and reported that he has no problems with the improvements requested and will report back as needed.

Hebden provided the signs to be replaced.
