## **MINUTES:**

It was moved by Sheneman, seconded by Dewey to approve the March 13, 2019 meeting minutes as written. Motion carried – Unanimous.

## **OLD BUSINESS:**

Trumble reported that he, Barnard and Smith met on April 8, 2019 to discuss FHT Ordinance Section 3 Decks and Patios in the buffer zone. The meeting addressed the interpretation and definition of "ground level" when issuing and enforcing standards. All agreed that the Zoning Administrator define ground level beginning at 7.5 inches for raised boardwalks, walkways, and all decks along the buffer zone and that the Planning Commission review the definition of "ground level" and propose clear language for future amendment of the Zoning Ordinance Section 3 Decks and Patios. Discussion followed.

Cran reported that she continues to get verbal complaints for property owned by Steve Bacon. Discussion followed.

## **NEW BUSINESS:**

Cran reported that the group <u>Friends of Veterans</u> are planning to place flags at the cemetery and Motorcycle Touring Groups have chosen Bellaire as their #1 destination in Michigan and will be touring in the near future.

Trumble reported that the Bellaire Boy Scouts place flags at cemetery yearly prior to Memorial Day.

Sheneman asked Barnard if anyone has approached the Township regarding Barn Events. Stating that these types of venue sites are becoming very popular.

Barnard reported that he has not had any inquiries and if a Special Use Permit and site plan application were filed, he would submit the application to the Commission.
