This will be a very large project and will be broken down into several phases. Plans are very similar to FHT Cottage Drive Park and cost is a factor for the commission. Phase 1: Estimate will cost \$15,000.00.

It was a consensus of commission that Phase 1 of Gorham Beach Park Beach Installation proposed site plan drafted by Corey Arsnoe be presented to the FHT Board for approval at an estimated cost of \$15,000.00. Crandall will present to FHT Board at their next meeting.
