PLANNING COMMISSION FOREST HOME TOWNSHIP MEETING MINUTES MAY 3, 2023 @ 7:00 PM

AGENDA:

Moved by Sheneman, and seconded by Cran, that the commission approve the agenda as amended. Motion carried – all present voting yes.

PUBLIC COMMENT:

The Chairman requested public comment. There was no public comment. Public comment closed at 7:03 p.m.

ZONING ADMINISTRATOR – STEPHEN BARNARD Update:

Windward Shores-Condominium Units – 5812 SE Torch Lake Drive

- Casey Clement of the Health Department of Northwest Michigan as notified both the Township
 and Donald Uzarski that <u>no</u> final approval will be granted for any septic installations until the
 zoning conflict has been resolved.
- Cannot prohibit condominium projects as long as the project complies with zoning ordinance.

<u>Michigan Township Association – Annual Conference attended:</u>

One topic of conversation was on the decisions of the townships: Zoning Decisions

James Wikman – 6032 SE Torch Lake Drive- Letter:

A letter dated <u>November 21, 2022</u> from James & Milissa Wikman regarding his neighbors to the north constructed a fence separating properties. Reporting that the fence was constructed in direct violation of Section 313 of the FHT Zoning ordinance.

- 1. Section 3, point A., part 1: Request for a copy of permit if one was issued.
- 2. Section 3, point A., part 2: No fencing in excess of three (3) feet in height shall be located within a required front or waterfront yard area or within the clear view area as defined. The fence was originally built several years ago and roughly 8 feet in height all the way to the waterfront. After speaking with the Zoning Administrator, he reported that the owner had cut down the fence to less than 3 feet, for the first 50 feet from the waterfront.
- 3. Section 3, point A., part 3: Any fencing or wall with a single finished side shall be installed with the finished side facing the neighboring property or road right-of-way. Violation: Not only is his view blocked to the north, we have to look at the unfinished 2x4's, and electrical wiring/junction boxes.

Mr. Wikman sent a follow-up memo dated <u>April 12, 2023,</u> stating that he had expected to receive a response as requested in his November letter.

Discussion followed.

Linda Cran, Secretary of the FHT Planning Commission will compose a letter answering Mr. Wikman questions.

Attorney – FHT Zoning Ordinance Section 313:

- A 30 feet long fence is too long.
- Weaver fixed the height of his fence in October or November of 2022 and the fence height is no longer in violation.
- Ordinance requires that the finished side of a fence be facing the neighbors' property. Option:
- Reverse fence, fence installed several years ago, and after fence reduced to 30 inches no longer a violation.
- Recommendation is that the commission continue to discuss the Zoning Ordinance and add Section 3 fencing language to review list.

Discussion followed.

Section 313 Fencing and Screening:

- Amend ordinance to define "FINISH"
- Amend ordinance to read both sides of wooden board fence be finished

Complaints Reported to Township:

The majority of complaints received are fence related.
