

FOREST HOME TOWNSHIP
PARKS AND RECREATION COMMISSION
TOUR AND ASSESSMENT OF ALL PARKS AND ROAD ENDINGS
May 10, 2023

Tour begin at 5:15 p.m. with all members of commission present and Corey Arsnoe.

Gorham Beach Park:

Meeting with representatives from DNR on May 30, 2023 at 1:00 p.m. to discuss and review draft of Phase I plans for improvements. Crandall to confirm and report at the next regular meeting Wednesday, May 17.

Check into having a newer outhouse placed at the site and check with Antrim County Road Commission on grading of road due to plow trucks using site to turn and/or push snow.

Intermediate Lake/Snowflake Road Ending:

Did not stop at this site – Corey reported that he recently mowed site and saw no issues.

Torch Lake Family Park:

Spotted a dead tree to be removed by Corey’s crew and continue to watch others. Some erosion issues along trail to water and Corey will add a ton stone.

620 Road Ending/Meeders:

Right side of entrance along the edge of road needs work due to snowplows pushing snow.

Jacob’s Road Ending:

Corey reported in good shape and did not evaluate.

Pinnel Road Ending:

Site is beautiful with the terracing of rocks.

Along fencing of parking area, add a berm and 6 to 8 planting to absorb water flow into site.

Add mulch as needed to walkways.

Steiner Road Ending/Sunset Torch Condo:

Left side of site Mr. Weaver has placed net fencing at the end of his wooden fence towards the water.

Discuss with Zoning Administrator to see if he can resolve issue.

Dockside Road Ending:

In good shape needs no improvements.

DNR/Dewey Boat Launch:

Some erosion issues at the water’s edge and resolve by pulling rocks back that have washed into the lake and add additional rocks if needed.

Arrowhead Park:

Replace one (1) section of split rail fence.

Repair plate at the end of the base that the dock is attached.

Green Street/Niepoth Road Ending:

Install 20 feet of dock at above water 10 or more inches.

FHT Cottage Drive Family Park/Miley's:

Place 10 or more yards of good sand on beach side of park.
Polarmo trees have not been removed with deadline approaching June 1.
It is unknown if an appeal has been filed with the court.

Pleasant Street Road Ending:

In good shape.

Lynn Road Ending/Lake Bellaire:

Corey reported site is in good shape and did not stop.

Lessard Lane Road Ending:

Corey reported site is in good shape and did not stop.

Eckhardt Road Ending:

Corey reported site is in good shape and did not stop.

Loon Preserve:

In good shape.

Grass Lake Road Ending:

Corey reported site is in good shape and did not stop.

The Meadows: 30 Acres

Corey reported site is in good shape and did not stop.

Order signs that say: **NO BUTTS** (cigarette butts) tossed into the grills and a pain to remove.
